Automated External Defibrillators are portable medical devices that analyze heart rhythms and can deliver a controlled electric shock to restore normal heart rhythm in individuals experiencing sudden cardiac arrest. A cardiac emergency can happen anytime, having rapid access to AEDs significantly increases the chances of survival. Sergeant Ivan Dike of the Umatilla Police Department expressed gratitude for the foundation's support, stating, "I'd like to thank the Good Shepherd Community Health Foundation for the award of funds for purchasing new AED's for our patrol vehicles. If it weren't for organizations like yours, small agencies like ours would have trouble getting the finances needed to get the lifesaving equipment. The importance of having AEDs' in our patrol vehicles is so important as Law Enforcement can arrive anywhere from 2 to 5 minutes before EMSS. 2 to 5 minutes could be the difference between life and death. So, with that being said, we are one step closer to being able to have an AED in each patrol vehicle.
