1) MEETING CALLED TO ORDER

5.1 General Announcements

Manager Stockdale stated that there had been a lot of questions in regards to the pop up concert. He wanted to clarify that it was a private event and not sponsored by the City. The event had been vetted by OHA and Umatilla County Health. The event hosts had gone through OLCC to obtain their special permit. The State had built a box to how outdoor events could be hosted. The organizers had complied and obtained all permits needed to host the event.

He also wanted to ask council if Staff could sell back vacation without having to use the equivalent amount. This would keep the City's liability limited and it would be a great morale booster for staff. Council supported this endeavour.

5.2 COVID-19 Update. We will discuss our grant program for businesses, CARES Act Reimbursement funds and preliminary economic development committee, masks requirement and City facilities, and general update.

Staff had only received a few applications. Anyone who gets a business license will be notified twice. The County was getting 2.3 million. Half would go to

cover operating expenses to manage the pandemic and half would go for economic development. The goal was to not lose a business in Umatilla due to the closures.

12.1 Hydraulically Connected Wells Feasibility Project loan modification

In March, Council approved Resolution 49-2020 to enter into a loan agreement with Business Oregon's Infrastructure Finance Authority for our Hydraulically Connected Wells Feasibility Study. Now that project has been awarded a corresponding grant and after review of total funds available for the entire scope of the project, there is a likelihood that the City's grant match (which is being paid for utilizing this loan) requirement may increase due to increased costs associated with environmental and cultural resources requirements. This item is intended for informational purposes and further discussion only. At the completion of the project, staff anticipates bringing an updated amendment to Council requesting an increase to the loan of an estimated \$50,000.

12.2 Inter-governmental Agreement with the City of Echo to provide Planning and Building assistance

For the first time in 3 decades, there is a residential developer interested in building more than 50 single family homes. City of Echo's new city manager has public works experience, but not planning and building experience. Soon we will have our own inspector and electrician which will enable us to provide these services. We are willing to donate the first \$10K as an in-kind donation, after that City of Echo will have to pay to cover the remaining costs.
