1. **RFP Questions**

Q1: May we have a copy of your current policy to review?

A1: Yes, a copy of our coverage declarations is attached to this addendum.

Q2: Do you have any scoring criteria or numeric ratings by question? If so, may we see what that will look like?

A2: Proposals will be evaluated on the following criteria. As they will not be weighted or prioritized, each item will be worth 25 points for a total of 100 possible points.

- A. Experience and Qualifications
- B. Public Sector Pool Experience
- C. Compensation
- D. References

Q3: Who is your current health insurance carrier?

A3: Our health insurance is through CIS. We offer the CIS Copay F RX7 plan with CIS Vision-A and the hearing aid and alt care riders and give our employees the option of Willamette Dental-A or CIS Dental II with orthodontic rider.

Q4: Do you have any upcoming operational or event plans for the City that could require insurance coverage outside what's currently provided by your existing policy? Such as an inflatable park at the marina or a music festival?

A4: The City is putting on its' first major three day music festival, Rock the Locks, in October 2023. This will be an annual event requiring special event insurance. We also have our annual Landing Days event in June which includes a parade, vendors, kids' games, live entertainment. We have previously explored the idea of an inflatable water park but at this time, the permitting and environmental considerations have made that an unviable option. We also have special insurance policies for pollution coverage of the marina fuel tanks and liability for the NFL Flag Football program put on annually by our Parks & Recreation department.
